### Rental Application and Policies:

Charleston Metro Homes is committed to treating all applicants equally. The following policies have been established to ensure compliance with applicable laws.

Perspective Tenants: Please read the following policies. We encourage all parties who feel they meet the guidelines to submit an application. An incomplete application will not be considered. Application for a property in no way implies that the applicant will be approved.

#### **Applicants**

- Each occupant 18 years of age or older must complete and sign an application.
- If a co-signer is necessary, the co-signer must also complete and sign an application.
   Acceptance of a co-signer is subject to individual consideration and approval by Charleston Metro Homes.
- To process the application, a \$60.00 non-refundable application fee per applicant or \$95.00 non-refundable application fee per married couple is required. Checks payable to Charleston Metro Homes.

#### Credit Criteria

- Charleston Metro Homes shall obtain a credit report for each applicant and co-signer 18 years of age or older. We will not accept reports supplied by any other party.
- If you are in bankruptcy, preparing for bankruptcy, or have been dismissed from bankruptcy, your application will not be considered.
- If you successfully completed bankruptcy and have been discharged, your application will be considered.
- If you have incurred a foreclosure or short-sale of your home, but credit history of other payments is positive, we will consider your application.
- If you credit score is below 650, you may be required to provide a higher security deposit or amounts for prepaid rent. This will be contingent upon rental history and credit payment history.

#### Income Criteria

- Applicant's gross monthly income should be at least three times the amount of monthly rent.
- Self-employed applicants must provide their most recent tax return and three months of bank statements.
- Unverifiable income will not be considered.

# Pet Policy and Application

Charleston Metro Homes Real Estate is proud to be a leader in Charleston, SC for pet friendly rentals. Pet owners have been pleased to find properties available that are comfortable for them and for their pet, as all too often pet owners are hard pressed to find a quality rental that is also pet friendly.

Charleston Metro Homes Real Estate has a very basic pet policy. Most of our properties allow almost any pet you could imagine! We have had mastiffs and chihuahuas, cats and mice (not together of course), snakes, ferrets, birds and rabbits. We understand that a pet plays a significant part in many people's lives, so we strive to allow most animals in most of our rental properties. Please make sure to ask if the property that has caught your eye accepts pets.

The only general restriction we have is that your animal must be one year of age or older. We are willing to work with some puppies and kittens, depending on age and training and the general application information of their owners; however this is handled on a case by case basis and you can expect to submit a minimum \$250 deposit in addition to the pet rent you will pay on a monthly basis (pet rent will be charged according to the anticipated full grown weight of your animal). If you have several pets, please call to make sure that we have a property suitable for a large number of animals. Regardless of prior consent, Charleston Metro Homes Real Estate reserves the right to have any pet removed from the property if it is determined that the pet poses a threat to the safety or condition of the property or any people in the property or the community.

Charleston Metro Homes charges pet rent each month for each of your animals. The term "pet rent" is simply rent you will pay for the allowance of your pet to occupy the rental unit with you. Pet rent is charged on a monthly basis and is paid with your rent.

The charges for pet rent as follows for different types and sizes of animals:

Caged animals (per cage)	\$10
