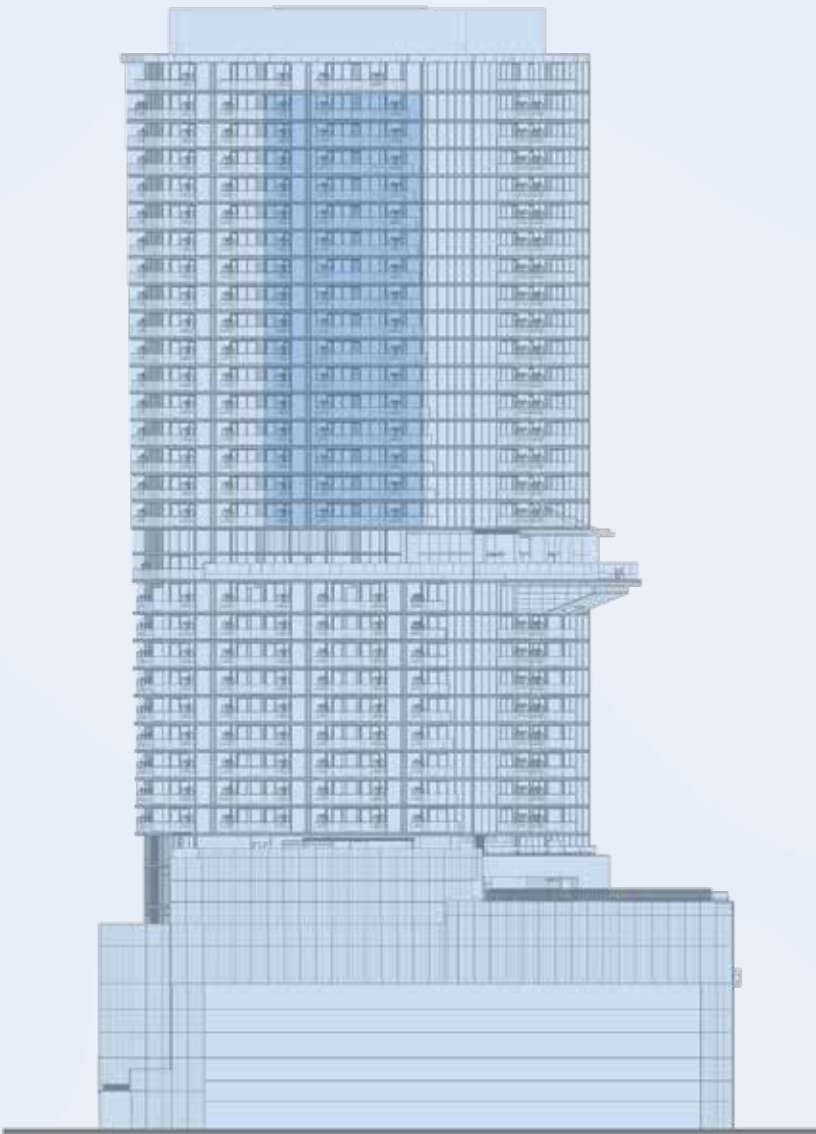

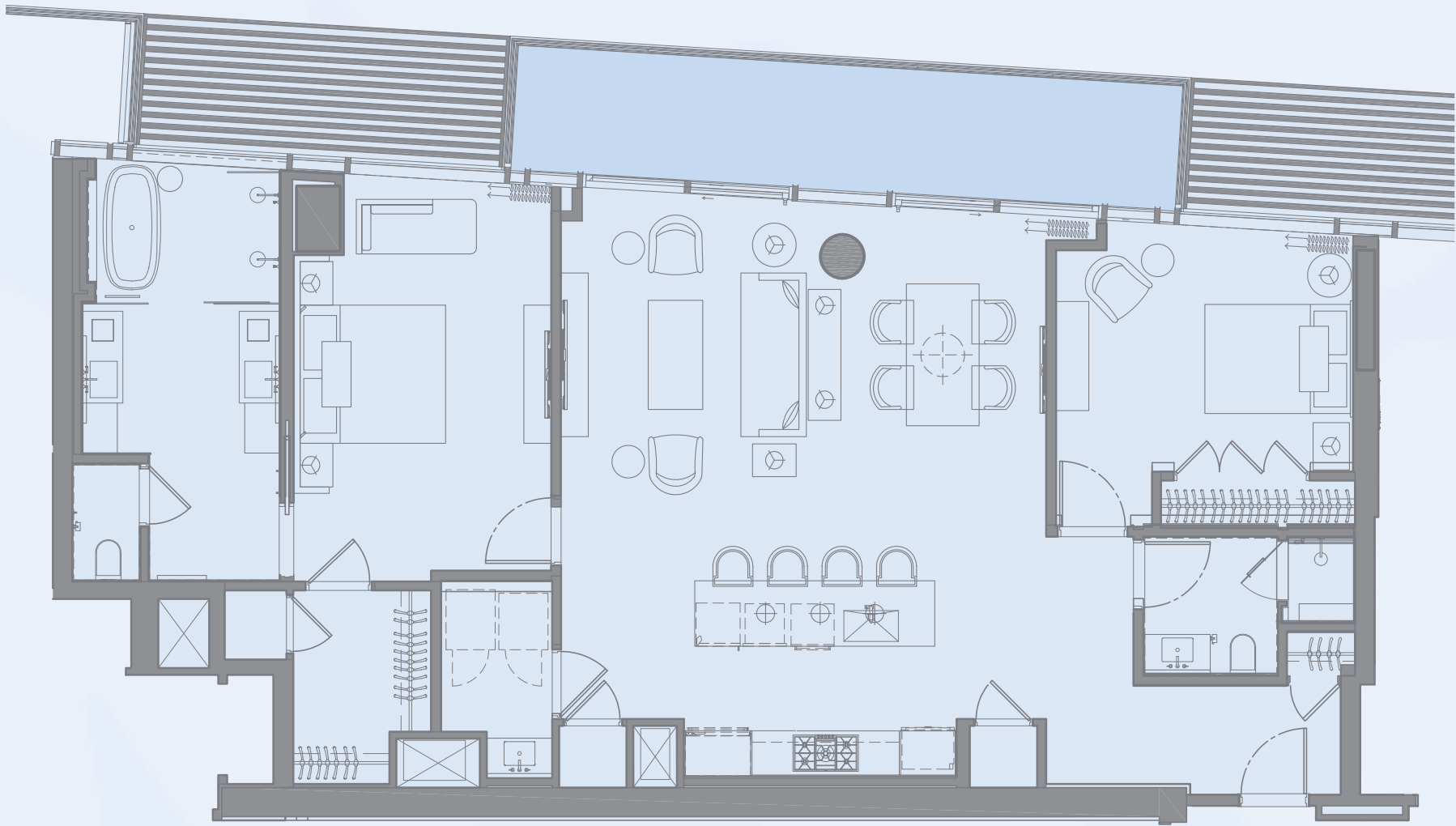
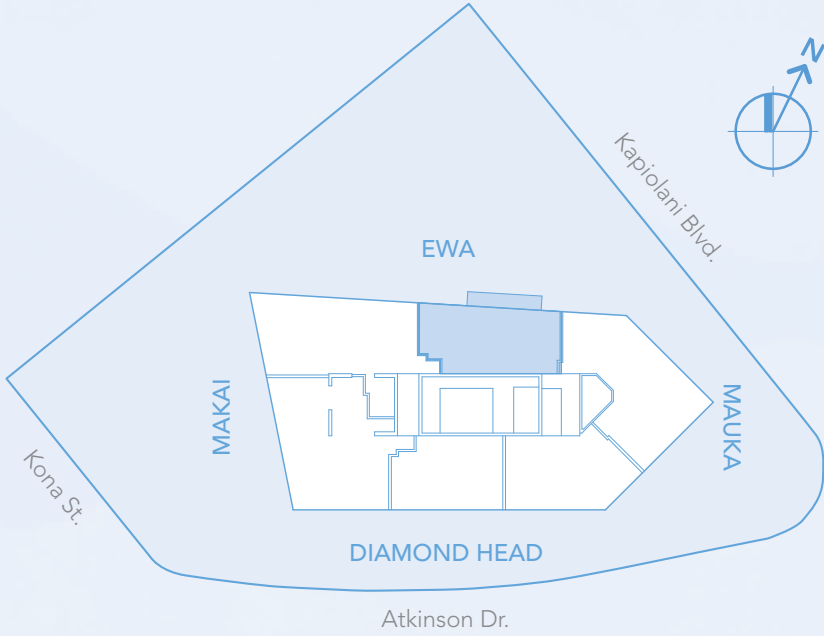

Within the exquisitely imagined interiors, spaces flow freely from one into the next, with natural light drawn from floor-to-ceiling glass, and gentle breezes coaxed from a spacious lanai off the living and dining areas.

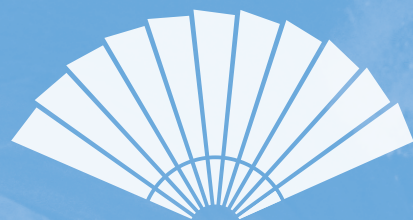
