### MEMBERSHIP FEES & CLUB ACCESS

All Mirasol title owners are required to pay the Recreational Facilities Maintenance Contribution ("RFMC") and all applicable dues and assessments for the membership category at closing. Fees for each category including use charges are based on the respective category acquired with the Unit. Each "Family Unit" is defined by the By-Laws as the title owner and their spouse/significant other and their unmarried children under the age of 24.
