- 4. Previous rental history reports from landlords must reflect timely payment, sufficient notice of intent to vacate, no complaints regarding noise, no disturbances, no NSF checks, no damage to unit or failure to leave the property clean and without damage at time of lease termination and no evictions.
- 5. We will **not** provide you with the credit report. We will provide you with the name of the credit reporting agency so you may receive a copy. A criminal background, a sexual predator background and eviction check will also be run.
- 6. Owners are contacted for approval and all decisions relating to the property. Tropical Realty & Investment of Brevard does not make the final decision regarding approval or declining applications.
