Tropical Realty Rental Application Process

1. You must fill out this application in full. No blank spaces. **EACH ADULT OVER THE AGE OF 18 MUST FILL OUT AN APPLICATION, THERE WILL BE NO EXCEPTIONS.**
2. A copy of a drivers license (or some form of picture identification) for each applicant must be provided with this application.
3. **A non-refundable, \$50.00 application/credit/background check fee for the EACH APPLICANT over the age of 18. No application will be considered without application fee. No exceptions. Fee must be paid in cash, money order, or by cashier's check. (NO PERSONAL CHECKS) to :Tropical Realty & Investments of Brevard**

4. Previous rental history reports from landlords must reflect timely payment, sufficient notice of intent to vacate, no complaints regarding noise, disturbances or illegal activities, no NSF checks, no damage to unit or failure to leave the property clean and without damage at time of lease termination and no evictions.
5. We will not provide you with the credit report. We will provide you with the name of the credit reporting agency so you may receive a copy. A criminal background, a sexual predator background and eviction check will also be run.
6. Owners are contacted for approval and all decisions relating to the property. Tropical Realty & Investment of Brevard does not make the final decision regarding approval or declining applications.
7. Tropical Realty will contact the applicant, to let them know whether the owner has approved or denied the application.
8. **Once approved, applicant must give the security deposit (cash, cashier's check or money order only), to hold a property off the rental market, an approved application alone, does not guarantee you the property, nor does a deposit without an approved application, you must have an approved application as well as the security deposit to remove a property from the rental market.**
9. **In the event the application is approved and applicant fails to enter into a lease, the applicant will forfeit this deposit. In the event the application is approved, this deposit shall be applied to the required security deposit. Please initial here _____.**
10. Prior to move in, and before keys will be given out, you must sign your lease and pay all money due (cash, cashier's check or money order only). Tropical Realty Property Management Merritt Island office will let you know how much is due prior to signing the lease.

Resident Selection Criteria

1. Our property management staff runs a credit, criminal sexual predator and eviction check. We also get verbal and/or written verification of employment and rental history. Applicants must have a combined gross income of at least three times the monthly rent. Self-employed applicants must turn in proof of income with this application in order for it to be considered. Proof of income would be two years of signed tax returns and three months' worth of bank statements.
2. The house will be handled to you in the condition you last saw it in. If you would like any modification to be made prior to your move, you need to make a request as part of request to lease the property. Understand that those requests will be taken into account in evaluating your application.
3. No pets (with the exception of medically necessary pets) of any kind are permitted without the documentation required for service animals and/or specified permission of landlord in the lease document, an addendum to lease, a pet fee acceptable to landlord and/or an additional pet deposit or additional security deposit. Fees and deposits are waived with medically necessary pets. The following breeds will **NOT** be accepted **UNDER ANY CIRCUMSTANCES**: German Sheppards, Dobermans, Rotweillers, Pit Bulls (Staffordshire Terriers), Chows, Siberian Huskies, Akitas, Alaskan Malamutes, Presa Canarios, Wolf Hybrids or mixes containing any of these breeds.
4. Current occupancy standards are a maximum of 2 persons per bedroom.
5. If your home is in a community, you are required to follow the rules of the associations and all fines are your responsibility and need to be paid within 30 days or by the stated date, whichever occurs first.
6. Be sure to read and sign the maintenance sheet and ask questions if you are unsure how to maintain the home in which you live.
7. Any exceptions to these criteria will need to be submitted in writing to the rental agent, for presentation to the landlord, for consideration. If approval is then given for such exceptions additional security, Co-Signers, and/or additional advance rent payments may be required.
